

## LIMITED WARRANTY FOR D-WALL SOFTWARE

(Applicable for Canada only)

USE OF THE D-WALL SOFTWARE IS SUBJECT TO THE LIMITED WARRANTY STATEMENT BELOW AND THE LICENSE TERMS. BY INSTALLING AND USING THE SOFTWARE, YOU ARE AGREEING TO BE BOUND BY THESE TERMS. IF YOU DO NOT AGREE TO ALL OF THESE TERMS, DO NOT INSTALL AND USE THE SOFTWARE.

1. MITSUBISHI ELECTRIC SALES CANADA INC (“MESCA”) warrants to the Licensor that, for no more than ninety (90) days from the verifiable date of the original Software license or the verifiable date of D-WALL software installation as indicated on the proof of installation form (not to exceed 30 days from original license) (the “Warranty Period”). (1) the licensed D-WALL Software (the “Software”) will perform substantially in accordance with the functional description of the Software as indicated in the Instruction Manual; and (2) the media on which the Software is furnished will be free from defects in materials and workmanship under normal use for the Warranty Period. MESCA does not warrant that the Software will be uninterrupted or error-free, or that functions contained in the Software will operate to meet your requirements. If after notice within the Warranty Period, MESCA determines that the Software has failed to perform in substantial accordance with the functional description as described in the Software Instruction Manual and if such failure is not due to accident, misuse, modification or misapplication of the Software or other causes beyond MESCA’s control, then MESCA at its sole discretion may (a) return the price paid for the Software license, or (b) attempt to modify the nonconforming Software and make available the modified Software at no charge to the original Licensor, which at MESCA’s sole discretion may be fulfilled by means of modified software contained on a replacement disc or made available for download via the internet or email for customer installation. MESCA reserves the right to refund the purchase price as its exclusive warranty remedy. The foregoing shall be MESCA’s sole obligation under this limited warranty. All rights under this limited warranty of the Software are also subject to your acceptance of and compliance with the terms of the Software License Agreement applicable to the Software, and this limited warranty shall be null and void if the Software is modified or changed in any manner except as specifically authorized by MESCA.
2. This Limited Warranty applies to the licensed software and Warranty Period in the table below. To file a warranty claim that may be covered under this limited warranty agreement, you must notify MESCA within the applicable limited Warranty Period.

Failure to return the Software upon request by MESCA may result in MESCA charging the Licensor the full retail price of the replacement software. All shipping expenses including, but not limited to, freight charges, customs duties, import/export fees, and taxes are the Licensor’s responsibility.

THIS LIMITED WARRANTY DOES NOT COVER: Software that has been modified or altered; accident, misuse, modification or misapplication of the Software; operation or use contrary to instructions in the Instruction Manual, damage from excessive physical or electrical stress; damage caused by use of third party components or hardware; any damage caused by acts of God or other factors beyond the reasonable control of MESCA, such as but not limited to fluctuation in electrical power, lightning, or other acts of nature. This limited warranty also excludes replacement or repair where no defect in the Software is found.
5. THIS LIMITED WARRANTY IS THE ONLY DIRECT WARRANTY FROM MESCA. ANY EXPRESS WARRANTY NOT PROVIDED IN THIS LIMITED WARRANTY, AND ANY REMEDY WHICH, BUT FOR THIS DISCLAIMER PARAGRAPH, MIGHT ARISE BY IMPLICATION OR OPERATION OF LAW IS, TO THE EXTENT ALLOWED BY LOCAL LAW, HEREBY EXCLUDED AND DISCLAIMED. BY WAY OF EXAMPLE AND NOT LIMITATION, THE IMPLIED WARRANTIES OF MERCHANTABILITY, NON-INFRINGEMENT, AND FITNESS FOR ANY PARTICULAR PURPOSE ARE EXPRESSLY DISCLAIMED.

UNDER NO CIRCUMSTANCES SHALL MESCA OR ITS AFFILIATES BE LIABLE TO THE ORIGINAL LICENSOR OR ANY OTHER PERSON FOR ANY INCIDENTAL, SPECIAL, OR CONSEQUENTIAL DAMAGES, INCLUDING BUT NOT LIMITED TO LOST PROFIT, LOST DATA, OR DOWNTIME COSTS, ARISING OUT OF THE USE, INABILITY TO USE, OR THE RESULTS OF USE OF THE SOFTWARE, WHETHER BASED IN BREACH OF WARRANTY, BREACH OF CONTRACT, TORT, OR OTHER LEGAL THEORY, AND WHETHER OR NOT ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
7. This limited warranty is governed by and will be construed in accordance with the laws of Canada. Some provinces may not allow a disclaimer of implied warranties, or the exclusion or limitation of incidental, special or consequential damages. Consequently, the disclaimer and limitations set forth in Paragraphs 5 and 6 above may not apply to all Licensors
